

## **CIT Program**

Rising 8<sup>th</sup>, 9<sup>th</sup> and 10<sup>th</sup> graders looking for a great summer experience are encouraged to register for a Counselor in Training (CIT) position.

The Fletcher Summer Day Camp, Counselor-in-Training (CIT) program is a great option for students who are looking for their first professional experience. CITs should enjoy the outdoors and working with children. CITs play an essential role at Camp, they help counselors make sure all campers are engaged and having fun but are also responsible for other tasks. These tasks are designed to help them develop work skills and understand what it means to be a part of a professional team. CITs will also be responsible for planning and leading one special activity each week.

## **CIT Requirements:**

- Must be entering the 8<sup>th</sup>, 9th or 10<sup>th</sup> grade.
- Must attend a pre-camp training session on Saturday, June 4<sup>th</sup> from 9am-12:30pm at Fletcher Town Hall.
- A positive attitude and strong work ethic are required!
- Only (2) CITs will be accepted every one 3 week session
- CITs will be selected on a first come first serve basis. All CIT enrollments will be at the discretion of the Camp Director and Recreation Program Supervisor.
- CITs are expected to work from 9am 4 pm, Monday Friday. CITs can be dropped-off/pick-up early or later at the convenience of their parents.
- CITs will be able to attend one 3 week session during the summer.
- CITs will be expected to plan and lead one special activity each week. This could include, teaching new games or leading craft activities.
- CITs must agree to camp rules, regulations and discipline policy which will be reviewed during required training session.
- CITs can be dismissed from the program at any time (without refund) if work performance, as determined by Camp Director, is not satisfactory.

**CIT Sessions:** Session 1: June 12<sup>th</sup>-June 30<sup>th</sup>

Session 2: July 3<sup>th</sup>- July 21<sup>st</sup> Session 3: July 24<sup>th</sup>-August 11<sup>th</sup>

## **CIT Fees:**

Fletcher Residents: \$25 one-time registration fee plus \$150 per 3 week session. Non-Residents: \$25 one-time registration fee plus \$180 per 3 week session.

## **Registration:**

All CITs must complete a 2017 Fletcher Summer Day Camp Application, as well as the supplemental CIT Form. You may register beginning Monday, 26<sup>th</sup> at Fletcher Town Hall during regular business hours. Please remember only cash or check is accepted.
