## **News from the April Town Council Meeting**

This meeting was held electronically due to the current COVID-19 social distancing and 10-person gathering requirement as implemented by the Henderson County Emergency Order Supplemental Proclamation.

- A two-year extension was approved for BSC Holdings, Inc. to complete the infrastructure at 150 Cane Creek Road.
- Eric Rufa, Planning & Zoning Director, discussed a proposed amendment to the rules of procedure for the Planning Board and Zoning Board of Adjustment which addressed meeting cancellations during a declared emergency. The amendments were approved.
- Mark Biberdorf, Town Manager, provided an update on COVID-19 response efforts by the Town noting that to date we have had minimal impacts upon our services.
- Rebekah Robinson, of Conserving Carolina, and Michael Luplow, of Fern Leaf Charter School, presented a request to submit a PARTF application for the Summit Park project. The application was not approved last year so they would like to resubmit it this year. The Town Council approved the resubmission of the application.
- Councilman Preston Blakely proposed adding a social media avenue to our current Town of Fletcher communication platform. He recommended using Facebook as an additional way of engaging with the public. Town Council approved the creation of a Town Facebook page and Town Manager, Mark Biberdorf, will determine how it will be maintained.
- Councilman Preston Blakely proposed creating an ongoing unpaid 20 hours/week intern program with a local higher learning institution. After discussion, it was suggested that we establish and formalize a program and policy for an unpaid internship to work with the Town Council and Town Staff. Mark Biberdorf will direct this formalized process.

### **Have you completed your 2020 Census?**

You should have received your 2020 Census questionnaire by now. Although we continue to battle the COVID-19 virus, your response to the Census, even though required by law due to the US Constitution mandate, is still very important. The Census results directly impact federal funding for our Town and County and the number of voices North Carolina has in the US House of Representatives.

So take a few moments and complete your Census form online at <a href="https://my2020census.gov/">https://my2020census.gov/</a>. It will take less than 10 minutes to complete if you know everyone's birthdate that was living in your house on 4/1/2020. Rather than having a Census Taker visit your home in June, or after depending upon the COVID situation, gather your information and take a few moments to complete your form today.

## Things You Can Do to Help Prevent Stormwater Pollution

- 1) Scoop up after your pet, even on the grass.
- 2) Make sure your septic system is in good condition, and have it maintained regularly.
- 3) Apply fertilizers and other garden products sparingly. If anything ends up on a hard surface, sweep it back into the grass or dirt.
- 4) Plant, mulch, or contain any areas of bare soil.
- 5) Never dump anything down a storm drain. "Only rain down the drain!"
- 6) Consider installing a rain garden, rain barrel, porous pavement, or other landscape feature to capture run-off from your roof and driveway.
- 7) Make sure your business disposes of all liquid and solid waste appropriately. Make sure dumpsters are covered, and never dump anything, liquid or trash, on the ground or pavement.
- 8) If you use chemicals, oil, solvents, etc., store them in good quality containers. Only pour them in an area that has containment structures, such as a berm around the area, to catch spills.

The Town has an ordinance to prevent "illicit discharges" into the stormwater system. ### **Governor Cooper's State Reopening Plan**

On April 23<sup>rd</sup>, Governor Roy Cooper issued Executive Order No. 135 extending, through May 8th, the Stay At Home order and orders limiting mass gatherings to 10 persons, requiring social distancing, restricting visitation at long term care facilities, extending closure of restaurants for dine-in service, and closure of other close-contact businesses. The Governor said NC has not yet seen a downward trend of those metrics needed to gradually begin lifting restrictions. He shared details about the plan to lift NC restrictions in three gradual phases once the data shows that testing, tracing, and trends metrics are headed in the right direction. The 4 main trend metrics being tracked include COVID-like syndromic cases over 14 days, lab-confirmed cases over 14 days, positive tests as a percentage of total tests over 14 days, and hospitalizations over 14 days. As of April 23rd, the last 3 metrics continue to trend upward in North Carolina. Testing and tracing are also a part of the equation to ensure that we continue to identify who has the virus, who has been exposed, and to help ensure we keep a 30 day supply of personal protective equipment on-hand for our critical healthcare and frontline workers.

The reopening process is projected to take several weeks using the phased-in approach. Highlights of Phase 1 include continuing a Stay At Home order but people can leave home for commercial activity with those retailers and services implementing social distancing, cleaning and other protocols; gatherings limited to no more than 10 people; and face masks recommended in public. Phase 2 is proposed to begin at least 2 - 3 weeks after Phase 1 and would include lifting the Stay At Home order with strong encouragement for vulnerable populations to continue staying at home; allowing limited opening of restaurants, bars and other businesses that can follow strict safety protocols with reduced capacity; allow gathering at houses of worship and entertainment venues at reduced capacity; and increasing the number of people allowed at gatherings. Phase 3 is projected to occur 4 - 6 weeks after Phase 2 and would lessen restrictions for vulnerable populations with encouragement to continue practicing physical distancing; allow increased capacity at restaurants, bars, other businesses, houses of worship and entertainment venues; and further increase the number of people allowed at gatherings. Governor Cooper indicated that if there is a spike in infections, tightening of restrictions may be needed temporarily. On April 24th, the Governor announced that public schools will remain closed for the remainder of this school year but will continue with remote learning. He also proposed a budget for the State's \$1.4 billion in Federal funds from the CARES Act addressing three immediate needs, including assistance for small businesses with applications beginning 4/27/20.

#### **Henderson County Post COVID-19 Task Force**

Henderson County has established a Post COVID-19 Task Force led by County Commissioners Bill Lapsley and Rebecca McCall and consisting of representatives from restaurants, retail stores, hair salons, real estate, healthcare, manufacturing, breweries, agriculture, schools, churches, lodging and the camp industry to make recommendations for opening the Henderson County economy after the Governor begins reopening NC. The Task Force also recently sought input from Henderson County businesses via a survey, to which approximately 250 responded, with the survey being open until May 1st. ## **COVID Impact on Henderson County**

Henderson County has shared some specific information about the impact of COVID-19 in our county. As of 4/28/20, here are our statistics:

- 1,501 COVID tests administered in Henderson County
- 158 cases in Henderson County
- Ages: 0 19 = 2%, 20 39 = 6%, 40 59 = 21%, 60 79 = 35%, 80+ = 37%
- 134 cases associated with long-term care
- 1 case in Fletcher
- 16 deaths, 44% were age 60-79, 56% were 80+

#### No Shortage of COVID-19 Scams

#### **IRS Get My Payment Tool**

Don't give up on using the IRS "Get My Payment" tool at <a href="https://www.irs.gov/coronavirus/get-my-payment">https://www.irs.gov/coronavirus/get-my-payment</a>. Their site is only updated once daily, during the night, so you only need to check once per day. Some users are getting a "Payment Status Not Available" message, which will go away unless you are not qualified to receive a stimulus check, so keep checking. The IRS is using that tool to indicate your payment status, your payment type, and whether they need more information from you, including your direct deposit bank account information.

#### **Caution Still Advised**

With our Governor's proposed plan to reopen our state in phases, everyone is getting anxious to get out of the house. Please keep in mind however, that the CDC still cautions that 3 main groups of people remain at high-risk for severe illness from this virus: (1) those 65 years and older; (2) people living in a nursing home or long-term care facility; and (3) people of any age with underlying medical conditions that are not well controlled. Those include people with chronic lung disease or moderate to severe asthma, serious heart conditions, people who are immunocompromised (many conditions can cause that such as cancer treatments, smoking, bone marrow or organ transplantation, immune deficiencies, poorly controlled HIV or AIDS, and prolonged use of corticosteroids and other immune weakening medications), severe obesity (body mass index of 40 or higher), diabetes, chronic kidney disease undergoing dialysis, or liver disease. So when you start to get out and about, if you know of anyone within these 3 categories or encounter someone who may be within one of these high-risk groups at the park or the grocery store, etc. please be courteous to your neighbors and practice social distancing. ## **COVID-19 Updated Symptoms**

The CDC has updated its list of possible COVID-19 symptoms which may appear 2-14 days after exposure to the virus and may range from mild to severe:

- Fever Cough
- Shortness of breath or difficulty breathing
- ▶ Chills ▶ Repeated shaking with chills
- ▶ Sore throat
  ▶ New loss of taste or smell



## **Best Practices for Using the Park**

- Bikes and skateboards = Helmets needed
- Dogs = Leashed everywhere
- Picnic areas = No groups larger than 10
- Walking or running = Social distance @ 6 feet
- At the back of the park = stay on the path, crops are now planted in the fields
- Restrooms = Closed, but Porta Johns available
- Trash = Take it back home with you
- Hands = Wash, before coming & leaving park
- Time = Visit, don't spend the day so the park won't become too crowded
- Team sports = Not yet in the park



## 2020 Property Tax Relief Applications Must be Received by June 1, 2020

NC provides 3 types of tax relief based upon age and/or disability which an owner can receive the benefit from one: **Elderly or Disabled Exclusion**: Excludes the greater of the first \$25,000 or 50% of the appraised value of the permanent residence of a qualifying owner who is at least 65 years of age or totally and permanently disabled. The owner cannot have an income amount for the previous year that exceeds the 2020 tax year income eligibility limit of \$31,000. Benefit limitations may apply when there are multiple owners.

<u>Circuit Breaker Tax Deferment</u>: Taxes for each year are limited to a percentage of the qualifying owner's income who is at least 65 years of age or totally and permanently disabled. For an owner whose income amount for the previous year does not exceed the income eligibility limit for the 2020 tax year of \$31,000, the owner's taxes will be limited to 4% of the owner's income. For an owner whose income exceeds the income eligibility limit (\$31,000) but does not exceed 150% of the income eligibility limit, which for the 2020 tax year is \$46,500, the owner's taxes will be limited to 5% of the owner's income. However, the taxes over the limitation amount are deferred and remain a lien on the property. The last 3 years of deferred taxes prior to a disqualifying event will become due and payable, with interest, on the date of the disqualifying event. Interest accrues on the deferred taxes as if they had been payable on the dates on which they would have originally become due. Disqualifying events are death of the owner, transfer of the property, and failure to use the property as the owner's permanent residence. Exceptions and special provisions apply. You must file a new application for this program every year.

<u>Disabled Veterans Exclusion</u>: Excludes up to the first \$45,000 of the appraised value of the permanent residence of a disabled veteran whose character of service at separation was honorable or under honorable conditions <u>and</u> who has a total and permanent service-connected disability or who received benefits for specially adapted housing under 38 U.S.C. 2101. There is no age or income limitation for this program. This benefit is also available to a surviving spouse (who has not remarried) of either (1) a disabled veteran as defined above, (2) a veteran who died as a result of a service-connected condition whose character of service at separation was honorable or under honorable conditions, or (3) a service member who died from a service connected condition in the line of duty and not as a result of willful misconduct. Benefit limitations may apply when there are multiple owners.
