Approval of minutes-corrections, additions or deletions. (5/2, & 5/11)

No comments were made on the minutes at this time.

## **Council Updates**

Mayor Pro-Tem Bob Davy stated that he had been attending some additional training over the last few weeks and that he had some information from The Metropolitan Planning Organization and Henderson County Transportation Advisory meeting concerning current and upcoming DOT projects.

He stated that due to Budget concerns with DOT that many projects that were not already funded will be postponed/delayed and that there will be no new projects/contracts in the state of North Carolina.

I-26 from Asheville to Airport Road has been funded.

I-26 from Airport Road to Hwy 64 has been funded.

Hwy 64 from Hwy 25 that was going to be six lanes instead of eight lanes has **not** been funded. (Expects this to be pushed out)

The Sweeten Creek road widening project that was to widen it to 4 lanes has been pushed back to 2024.

The project on Old Airport Road is expected to be completed in September of 2020.

For your knowledge DOT gets their budget (funding) from the following:

50% Fuel tax

30% DMV fees

20% Sales tax from vehicle purchases

The projections from DOT for the fiscal year 2019/2020 is a projected **loss** of 208 million.

The projections from DOT for the fiscal year 2020/2021 is a projected loss of 566 million.

If we have a hurricane or a major landslide there is no money to fix it the state would have to find the money from some other fund.

The big shortfall with COVID and people not driving the fuel tax revenue is down dramatically. Also new car sales are down and more people are buying used cars instead of new.

The way DOT is dealing with the shortfall is that they are delaying contracts and, reducing staff. They let go of 400 contactors and temporary employees. Many programs are being suspended wildflowers, litter sweep, mowing along the roads, repairs and patching of pavement reduced, repairing railing along roads reduced, new traffic signals (that may be requested) will be reduced. Even before COVID hit they discovered that there was going to be a shortfall and are working on how to cover these expenses. The fuel tax could go up, sales taxes on vehicles could go up as well.

Driver's License and tag renewals have been given a 5 month grace period.

**Mayor Whiteside** stated is there any questions from council on the Consent Agenda?

**Town Manager Mark Biberdorf** stated that we have received more feedback on this proposed development than any other in a while and we are keeping track of all of it.

Mayor Whiteside stated that next week we will hear from the Henderson County Chamber.

<u>Public Hearing on presentation of the FY 2020/2021 Budget and approval of budget ordinance-Mark Biberdorf, Town Manager.</u>

**Mayor Whiteside** asked Town Manager Mark Biberdorf did he have any comments about the Budget presentation.

Town Manager Mark Biberdorf stated that we have not gotten any new value updates on property taxes from the county. We will essentially be going with the last set of values that we received. We can incorporate that into adjusting the sales tax figures down or up and we adjusted everything on the expense side from the feedback from the budget retreat. On the MVP's for the police department we did adjust the vehicle purchase down from 3 vehicles to 2 vehicles so that we can fund new MVP's for the police department.

Discussion Followed:

<u>Update on creation of a Facebook page for general town information-Mark Biberdorf, Town Manger.</u>

**Town Manager Mark Biberdorf** stated that working on the Facebook page I wanted to have a draft to show you on this. On the direction I was going with this it will be for informational purposes and not a public forum. We will have language up

there that states that this is for information and if you have questions we will direct them to our website and they can email and we can respond to their questions.

Council is ok with this format for a town Facebook page.

# <u>Staff report on discussion with Carolina Truffieres for lease or sale of Town</u> property-Mark Biberdorf, Town Manager.

**Town Manager Mark Biberdorf** you know we have had discussions with Brian Upchurch and Davis Upchurch from Carolina Truffieres. He has communicated back to us his first choice is to look at 10 acres of land with a lease to purchase option or outright purchase. He also outlined 50 acres with a lease to purchase option or outright purchase. You have a copy of a map in your packet and he is looking at something on the north side of the property.

# Comments from the Town Manager Mark Biberdorf.

On the Town Center project we are now down to one parcel on our land acquisition on Hwy 25. The land swap was finished a week ago and you will see that they have now moved all the cars and boats off the property. The one parcel left is the Kevin Walker property had with some Deed of Trust issues and they are being taken off.

The RFP's on the town center project started going out on May 18th to the public developer contacts that we had. I contacted WR Martin that we have used before and they have spread it out there and we are getting more company names to send it to as well. It is leading to interest Eric and I met with one group on Friday.

The Hwy 25 Corridor project is completed. The improvements are done and we are working on a punch list of items. Maybe next week I can tell you when we can get those done. These items will have to be finished before we can close the project out.

#### Discussion Followed:

We are checking out rescheduling the shred event but I am not sure about the pill drop. If we did this people would just drive up and dump their paper with little contact just waiting in their cars.

On COVID – 19 we ended our teleworking policy on May 18 and we opened Town Hall on May 26 and this has been going ok. We put signs up concerning wearing masks and social distancing. Public works has slowed down a little bit on the brush orders they were getting and the tonnage is coming down on the garbage collection. Parks & Recreation opened the dog park and the shelter pavilion. The playground and the fitness station is still closed.

On a final comment we are trying to be prepared with some of the demonstration that has been going on with the George Floyd issue. We want to be sensitive to everyone's feelings because a lot of people have been hurt by this.

Town Manager Mark Biberdorf stated that he would like to talk to the town attorney about maybe drafting a lease agreement of no more than 10 years with an option to purchase with other provisions in there as well. I would like to bring this back in July for council to discuss. Eric and I had a phone conference with Mark Williams of Agri Business of Henderson County. We talked about land sales and leasing in Henderson County. My recommendation is that we move more towards leasing the property as opposed to selling the property.

**Mayor Whiteside** stated that if we proceed with this I would be comfortable with the lease option. However at this point there are too many unanswered questions for me to make a decision and I would want to only be in a discussion phase at this point.

We have one property left on the Town Center project and that is the Kevin Walker property and we are waiting on the satisfaction of a Deed of Trust to come in so that we can set up our closing.

The RFP I mentioned earlier went out on the 18th (May) and we sent it out to about 30 to 35 individual companies and about 8 organizations we are getting good responses. I still hoping that we will get letters of interest by the June 15 deadline and June 30 for questions and September 30 for proposals.

On the Hwy 25 corridor improvements there is not much new from last week they have the punch list items and waiting to get that last payment out.

We are working on rescheduling the shred event we just don't have a date as of yet.

Mayor Whiteside asked for a motion to adjourn and it was so moved by Mayor Pro-Tem Eddie Henderson and seconded by Councilman Preston Blakely.
