# **News from the January 8th Town Council Meeting**

- By Consent Agenda, Town Council:
- Approved property tax releases from the Henderson County Tax Office.
  - Approved a fiscal year 23/24 audit contract with Lowdermilk Church & Co. for \$18,025.
  - Approved a language clarification update to Chapter 110 of the Fletcher Code of Ordinances changing "business privilege license" references to "business registration".
  - Approved a language clarification update and slight revisions to Chapter 111 of the Fletcher Code of Ordinances. References to "business privilege license" were updated to "business registration" and slight administrative changes were made to the process used to issue permits for temporary and door-to-door salespeople.
- A Public Hearing was held to consider Rezoning Request R-2023-01 to rezone 9 parcels on Cane Creek and Pressley Hill roads from R-2 to Neighbor Business District (NBD). These parcels fall within the "Heart of Fletcher Overlay" which identified them as a potential area for a NBD and the request was recommended by the Fletcher Planning Board. Eric Rufa, Planning and Zoning Director, noted there is no development proposed for these lots -- it is a general rezoning request. Attorney Bob Oast, representing the property owners, gave a presentation. Council voted to approve the rezoning request.
- A Public Hearing was held to consider an amendment to the Land Development Code (LDC) regarding building height in the M-1 zoning district. Eric Rufa explained that the issue arose after an inquiry from the Henderson County Partnership for Economic Development regarding a possible industry. The Fletcher Planning Board recommended amending Article 2 of the LDC to allow 56 foot high buildings (i.e. 4 stories) rather than the current 42 foot maximum for 3 story buildings. Town Council approved the proposed amendment.
- Mark Biberdorf, Town Manager, reminded Council that two developer groups, Windsor Aughtry and The Carland Company, had presented their interest and potential vison for the Fletcher Town Center project. Mr. Biberdorf asked Council their desire regarding next steps in this matter. It was decided to set up additional meetings with The Carland Company to ask some additional questions and seek clarification.
- Council discussed two local government committee vacancies resulting from the retirement of Councilman Bob Davy. New Councilman Jim Player volunteered to fill the vacancy on the French Broad River Metropolitan Planning Organization and the Henderson County Transportation Advisory Committee.
- Mark Biberdorf shared updates:
  - Staff has met with Rebecca Robinson, from Conserving Carolina, to help identify possible grant funds to assist with the extension of our greenway. One such possible grant has been identified, Connecting Communities to State Trails, and she will provide more details as they are finalized by the State. McGill Associates has identified a segment of our trail that could fall within this particular estimated matching grant limit.
  - A meeting was held with the Housing Assistance Corporation (HAC) to discuss the possibility of a multi-family workforce housing piece on the Town Center property north of Town Hall. It would be part of the mixed-used concept along with commercial; and although not a large number of units, should be impactful for workforce housing.
  - A meeting will be set up with Mr. Buster Brown to discuss the possibility of and answer questions regarding a cost-share approach partnership for construction of four additional tennis courts on Town property for which Mr. Brown has expressed an interest.

# **Property Tax Reminders**

- Personal Property Listing sheets for individuals and businesses are due by 1/31/24 to the Henderson County Assessors Office. If you need a listing form, go to <a href="https://www.hendersoncountync.gov/tax/page/forms-and-applications">https://www.hendersoncountync.gov/tax/page/forms-and-applications</a> or call the Henderson County Tax office at 828-697-4870. Failure to list your personal or business property, or list changes to your real property greater than \$100 in value, may result in a 10% late listing penalty and possible back taxes.
- When making a tax payment or viewing your tax balance on the Town of Fletcher website found at <a href="https://www.fletchernc.org/departments/finance/property-taxes/">https://www.fletchernc.org/departments/finance/property-taxes/</a>, please remember to utilize the "Pay Balances" option to view the total tax amount due including interest and penalties. The "View Tax Notices" option only shows the original billed amount without interest or penalties.

# **Town Ordinance Reminders**

Town of Fletcher ordinances address various aspects of life in Fletcher. Three ordinances which occasionally interest residents involve noise, animals, and door-to-door solicitation.

The noise ordinance prohibits "unreasonably loud, disturbing and unnecessary noise". Prohibited noise includes loud vehicle horns (except in emergencies), the keeping of animals which disturb nearby persons due to frequent or long continued noise, noisy unrepaired vehicles, playing of loud music between the hours of 11:00pm - 7:00am, etc. (info taken from chapter 90).

The animal control ordinance prohibits the keeping of an animal in such a way that creates a public nuisance. The definition of "public nuisance" includes allowing a dog(s) to bark continuously or intermittently for more than 30 minutes, create damage to another's private property, etc. (information taken from chapter 95).

The door-to-door solicitation ordinance requires that all paid solicitors must apply for and be issued a Town permit prior to any solicitation. This ordinance requires a background check, encourages residents to ask to see a solicitor's permit, and seeks public assistance in notifying our Police department of unauthorized solicitors in their neighborhoods (information taken from chapter 111).

Although our ordinances clarify acceptable and unacceptable behavior/actions in our Town, residents who exercise common sense and respect and consideration for their neighbors can help eliminate the necessity of the ordinance enforcement process.

# **Changes in Trash Pickup Times**

When we have bad weather, training, meetings, etc. sometimes our normal trash pickup time changes. In fact, in order to complete our trash routes on certain days we may utilize multiple vehicles -- which means we will probably arrive at your residence at a different time than usual. Although we do follow a route schedule which helps establish a "normal" pickup time, we cannot guarantee that is when we will pick up your trash. To keep your trash from being missed when our daily schedule changes due to workload, weather, or staffing, we ask that all trash be bagged, tied/closed, inside your cart, and sitting at the curb by 7:00am on your assigned pickup day. Thank you so much for your cooperation in helping us serve you.

# Free Mulch Giveaway

If your mulch was washed away by the January rains, here's an opportunity to get some free replacement mulch. We will be having a mulch giveaway on Saturday, February 17th from 8:00am - noon at our Parrish Municipal Drive location, off Howard Gap Road. The mulch pile is located beside the big green metal building. We will be available to help load as little or as much mulch as you want.

# From the Office of Chief Terry:

I wanted to remind residents the Fletcher Police Department has a prescription pill drop box located in the lobby of the police department. During 2023 the department collected 192 pounds of medications, equal to 144,120 pills as compared to 76 pounds, equal to 57,075 pills collected in 2022.

This is a service for residents to safely dispose of their unused and unwanted medications without having to travel any significant distance. This service reduces drug overdoses and drug abuse by reducing the amount of medications in our community and helps to protect the environment by keeping medications out of the water supply. This service is available Monday through Friday between 9:00 am and 5:00 pm.

Pills and other unused medications, to include powdered and liquid medications, should be transported to the Fletcher Police Department in their regular prescription containers. Residents should go to the front desk of the police department where an officer will assist the resident in submitting their unused medications for disposal.

Syringes, needles, and chemotherapy medications cannot be accepted. Information on disposing of syringes, needles, and other sharps can be found at <a href="https://safeneedledisposal.org/state-search/?state=NC">https://safeneedledisposal.org/state-search/?state=NC</a>.

Besides the collection box in the lobby, a pill drop/paper shred event is scheduled at Town Hall for Saturday April 20, 2024 from 9:00 to 12:00, so mark your calendars.

## **IMPORTANT VOTING INFO**

- Voters will be asked to present a valid photo ID when voting in person. An unexpired NC driver's license, a NC DMV non-operator ID, or a US passport are all acceptable. If you do not have a photo ID, you may obtain a free ID from the Board of Elections by 3/2.
- Early Primary voting will be held <u>ONLY</u> at the Henderson County Board of Elections office.
- This Primary election will include local, state, and federal races.
- To vote in this Primary, you must be registered as a Democrat, Libertarian, Republican, or Unaffiliated. The deadline to change party affiliation is February 9th.

# Fletcher Planning Board Vacancy

The Town of Fletcher is seeking to fill a vacancy on the Planning Board & Zoning Board of Adjustment. (ZBA members serve dual roles on the one Board). Functions of the Planning Board include recommendations to the Town Council on applications related to Rezoning, Conditional Rezoning, Special Use Permits, and text amendments to the Town's Land Development Code. The Board also reviews preliminary plats for major subdivisions as well as design review for projects in the "Heart of Fletcher" Overlay. Functions of the ZBA include quasi-judicial hearings regarding applications for variances and appeals on zoning matters.

An "At-large" seat may be filled by anyone who resides in the Town limits, and is not specific to a particular Council district. The Board typically meets once per month, on the 3rd Tuesday at 6:00 pm. Applications will be accepted through Monday, February 26, 2024. The Town Council is responsible for appointments to all volunteer Boards. Applicants would need to be available to attend a Council meeting as part of the process if requested.
